

REGULATION NO 1/2023

OF THE DIRECTOR OF DOCTORAL SCHOOL OF THE UNIVERSITY OF SZCZECIN

dated 7 February 2023

regarding the specification of the specimen of a certificate confirming the completion of the curriculum of a doctoral student of the Doctoral School of the University of Szczecin and a doctoral student's declaration regarding the submission of a doctoral thesis

Under § 8.3.14 in conjunction with § 36.2, § 37.1 and § 37.2 of the Regulations of the Doctoral School of the University of Szczecin adopted under a resolution of the Senate of the University of Szczecin No. 60/2022 of 28 April 2022 on the adoption of the Regulations of the Doctoral School of the University of Szczecin it is decided as follows:
